**Bert Harris** son of **Denver Harris** and **Margaret Curley Johnson** was born on 6 Sep 1900, died on 13 Jun 1922 at age 21, and was buried in Dalton Cemetery Dalton, Cheyenne County, Nebraska.

**Jack Harris** was born on 3 Aug 1921 in Nebraska, died on 30 Jan 2005 in Keith, Nebraska at age 83, and was buried in Saint Marys Catholic Cemetery Dalton, Cheyenne County, Nebraska.

Bill was born 22 Jun 1947 Dalton, Cheyenne County, Nebraska and died 16 Jan 2020 in Dalton. He is buried in Saint Marys Catholic Cemetery in Dalton Nebraska.

## 30 Jun 1922 - The Dalton Delegate

Bert was well on the way to building a farm. The family had been living on the Reinmuth farm and was probably working with his father-in-law. From his obituary:

"Bert was a hard-working, ambitious young man, honest to a fault, and was universally respected by his large circle of friends and acquaintances. He had just laid the foundation plans for a future of happiness for his wife and little one when he was felled by the terrible disease. *(Bright's Disease – kidney failure)* His passing will be mourned by the people of the community and the heartfelt sympathy of all is extended to the bereaved. # BERT HARRIS—CONTINUED

23 Jun 1922 - The Dalton Delegate

The death of Bert Harris occurred Tuesday afternoon at 2:15 at the home of his father-in-law, J. W. Reinmuth, west of Dalton, the death resulting from acute Bright's disease from which he had been a sufferer for about a year. Monday morning a change for the worse was noticed and from that time death was but a matter of hours. The subject of this sketch was born in Omaha, in September, 1890, and was aged 21 years and 8 months at the time of his passing. He was the son of Mr. and Mrs. Denver Harris, and removed with his parents when a baby to a farm in Burt county, Nebraska. Here the parents died when Bert was nine years old and he went to Oklahoma to reside with a sister where he made his home until five years ago when he came to this vicinity where he had made his home since. He was united in marriage in October, 1919, with Miss Angie Reinmuth, and to this union one son was born, he being now ten months old. The funeral is to be held this morning at 11 o'clock at the Presbyterian church, Rev. Samuel Light of Sidney having charge of the services. Burial will be made in the Dalton cemetery. Beside the wife and little son, three half brothers: Jas. Johnson of Lyons, Neb., Archie of Dalton, and Oliver Johnson of Burt county, Neb., and three half sisters: Mrs. Lee Senter of Hobart, Okla., Mrs. A. A. Sharp and Mrs. Guy Corrick of Sidney, are left to mourn the passing of this young man.
