Gregory Gibbs

Gregory Gibbs, son of **John Gibbs** and **Miss Grigory(Gregory)**, was born in 1635 in Charles Cittie Co VA and died about 1683 in Middlesex Co Va about age 48.

Gregory was the second child of John and Miss Grigory Gibbs. Gregory was the first generation born on America soil as he was born at Jordan's Journey, Charles Cittie County, Virginia. He died in 1683

The children of Gregory and Mary Gibbs are not in order of birth, most of the dates are Baptismal dates. They were the parents of nine children.

Gregory married **Mary ?** on an unknown date.

Children from this marriage were:

- i. **Thomas Gibbs** was born about 1672 in Charles Cittie Co VA and died on 4 Oct 1763 in VA about age 91.
- ii. **William Gibbs** was born about 1673 in Middlesex Co Va.
- iii. **Joan Gibbs** was born on 13 May 1674 in Charles Cittie Co VA.
- iv. **Penelope Gibbs** was born on 10 Aug 1676 in Charles Cittie Co VA.
- v. **George Gibbs** was born in 1677 in Charles Cittie Co VA.
- vi. **Mary Gibbs** was born on 14 Aug 1678 in Charles Cittie Co VA and died on 13 Sep 1726 in Middlesex Co VA at age 48.
- vii. **John Gibbs** was baptized on 10 Oct 1680 in Middlesex Co VA, died on 31 Jan 1725 in Middlesex Co Va at age 44, and was buried on 3 Feb 1725 at Christ Church Cemetery in Middlesex Co VA.
- viii. **Margaret Gibbs** was born on 6 May 1682 in Charles Cittie Co VA.
- ix. **Richard Willis Gibbs** was born on 9 Jun 1685 in Charles Cittie Co VA. <==== ??? Could be if the baptism was delayed.
- x. **Charles Gibbs**

WILLS AND INVENTORIES, 1673-1812 and OTHER COURT PAPERS, ORDER BOOK 2-1680- 1694 by William Hopkins, on page 135, it states: "Mary Gibbs widow of Gregory Gibbs, binds her son William Gibbs, age 10 to Mr. Richard Willis until age 21, November 5 1683; on page 308 George Gibbs, the orphan son of Gregory Gibbs, decd., is bound to Robert George for 10 years to learn trade of shoemaker, October 3, 1687."

From the VESTRY BOOK OF CHRIST CHURCH PARISH MIDDLESEX COUNTY, VIRGINIA,-1665, page 23, 1674/5: " It is order by the Sheriff Demand and Receive of Mr. James Blackmore five hundred pounds of Tobacco for Fine Due to ye Parish, he becoming security for Gregory (Grigory) Gibbs."
