John Gibbs

John Gibbs, son of **Gregory Gibbs** and **Mary (?)**, was baptized on 10 Oct 1680 in Middlesex Co VA, died on 31 Jan 1725 in Middlesex Co Va at age 44, and was buried on 3 Feb 1725 at Christ Church Cemetery in Middlesex Co VA.

John married **Mary Marron(Mullens)** in 1696.

Mary Marron(Mullens) was born in 1682 in VA and died in 1742 in Middlesex Co Va at age 60. (Mary Mullens, d 13 Sept 1728—CDXVIIC #24335)

Children from this marriage were:

- i. **Elizabeth Gibbs** was born on 22 Jan 1699 in Middlesex Co Va and died on 22 Oct 1716 in Middlesex Co Va at age 17.
- ii. **Stephen Gibbs** was born on 10 Jul 1700 in Middlesex Co Va. Another name for Stephen was Steven.
- iii. **John Gibbs** was born on 9 Oct 1702 in Lancaster Co VA and died on 31 Mar 1708 in Lancaster Co VA at age 5.
- iv. **Zacharias Gibbs** was born on 1 Feb 1704 in Middlesex Co Va and died on 16 Sep 1773 in Culpeper Co Va at age 69.
- v. **Marrin Gibbs** was born on 20 Apr 1707.
- vi. **Marran Frances Gibbs** was born on 30 Jan 1708 in Middlesex Co Va and died on 22 Oct 1772 in Orange Co Va at age 64.
- vii. **Mary Gibbs** was born on 22 Apr 1711 in Middlesex Co Va and died in 1778 in Fauquier Co VA at age 67.
- viii. **John Gibbs (XI)** was born on 5 Apr 1716 in Middlesex Co Va, died in Union Co SC, and was buried in Union Co SC.
- ix. **Anne Gibbs** was born in 1718.

Will of John Gibbs

In the Name of God Amen. I **John Gibbs** of the County of Middlesex in the Parish of Christ Church Being in sound and perfect memory thanks be to Almighty God for the same and Calling to Remembrance the uncertain Estate of this transitory life and that all flesh must yield to Death when it shall please God to Call Doe make Constitute Ordain and declare this my last Will and Testament Will and Wills heretofore by me made and declared either by word or mouth or writing and this isonny to be take for my Last Will and Testament and None other: I give and Committ my Soul unto Almighty God my Savior and Redeemer in whome and by Merrits of Jesus Christ I trust and believe afsured to be Saved and to have full Remition and forgivenefs of all my Sinnes past and that my Soul with my body; at the general Day of Resurrections shall rise again with Joy and Through the Merits of Christ's death and pafsion pofsefs and Inherit the Kingdom of Heaven prepared for the Elect and Chosen; and my Body to be buried in such place and Chrisitan manner where it shall please my Exec hereafter to appoint: And now for Setling of my temporal Estate a such goods Chattels and Debts as it hath pleased God for above my Derests, to bestow upon me I order give and Dispofe the Same in manner and form following: this is to Say, first I will that all those Debts and Duties I owe in right Contiance any person or persons whatsoever be Contended and paid or cause to be paid within Convenient time after my decease by my Executor hereafter Named.

Item I give and bequeath Unto my Darling and Loving wife Mary Gibbs all my Land to her and her heirs for Ever.

Item for all the Rest of my Estate both Reyall and perfonall I Lend my aforesaid Loving wife Dureing Her Natual life only one piece of Coined Silver Called twelve- pence to my Grand Daughter Elizabeth Roye: And my Desire is that my Estate both Reyall and perfonal before lent to my wife During her Natural life at her decease it be equally divided amongst my Children and if my Said wife Shall think fitt in her life time to Dispofe of my part of my Estate to any of my Children or Child that Such Child So Advance in the Life of my wife Shall have no greater Share than any of the rest of my Children Who shall have their part after her decease. My Desire in that my Estate be neither inventryed or Appraifed Laslty I doe Constitute and appoint my Dear and Loving wife my whole and Sole executrix of this my Last Will and Testament as witnefs my hand and Seale this fourteen day of June 1725.
